

Terms & Conditions

1. The **Luminous Power Technologies Partner program** is an exclusive program which has been designed by Luminous Power Technologies Power Technologies for its business associated on shop.haierindia.com platform which is managed by Brandbuddiez Technologies Pvt. Ltd. (hereinafter “BBTPL”)
2. shop.haierindia.com (hereinafter “Website”) is an online shopping portal provided by Haier Appliances India Private Limited (hereinafter called as “Haier”) for the range of Electronic Appliances in India. The terms and conditions contained herein along with the Privacy Policy and Agreement regulating our relationship regarding the use/access of website by you. You are advised to read this Agreement carefully before entering into a transaction on shop.haierindia.com. If you accept this agreement, it will be a legally binding agreement between you and Brandbuddiez Technologies Pvt. Ltd.
3. Your visit to this website is subject for the Payment, Delivery and Returns Policy and Terms and Conditions are available here on this website and shall be regulated through the same.
4. This website shop.haierindia.com is owned by Haier Appliances India Private Limited a incorporated under the Indian Companies Act of 1956 and operated by Brandbuddiez Technologies Pvt. Ltd. (hereafter “BBTPL”). The brand 'HAIER' belongs to Haier Appliances India Private Limited. and is being used on this site under a specific agreement by placing an order on this site, you are entering into a purchase/sale transaction with “BBTPL”. The money will be collected by BBTPL. This applies to all cases where the payment is made by modes i.e., all credit card, bank card, debit card, cheque, bank transfer and other payments are to be made to shop.haierindia.com
5. Your credit card or debit card statements will reflect Brandbuddiez Technologies Pvt. Ltd. In case of third-party statements including bank and credit card statements, the merchant’s name may appear in an abbreviated format.
